



## 2003 Annual Membership Meeting

The 2003 Annual Membership Meeting has been scheduled for May 8, 2003. It will be held at the North 6th office with registration beginning at 6:30 pm and call to order at 7:00 pm. When there is only one nominee for each position to be filled, elections will not be conducted by ballot and there will be no nominations from the floor.

Resumes are being accepted for two positions on the Board of Directors.

**Resumes must be received by the Nominating Committee by February 10, 2003.** Resumes must be accompanied by a signed certificate stating you will accept the office if elected. Basic qualification requirements are as follows:

- Be a member in good standing of the credit union.
- Have the ability and desire to attend all regular and special meetings of the board of directors and at least one educational and planning program each year. Have the ability to take and handle criticism for making necessary but unpopular decisions.
- Have an open mind, the ability to use sound judgment, a willingness to accept responsibility and the ability to make group decisions with fellow board members.

### NOMINATIONS MADE BY PETITION REQUIRE THE FOLLOWING:

- Petitions must be signed by 1% of the membership, approximately 140 members
- Petitions must be accompanied by a signed certificate stating the nominee agrees to being nominated and will accept office if elected.
- Petitions must be accompanied by a list of qualifications and biographical information to include:
  - A. Current occupation
  - B. Education
  - E. Qualifications
  - D. Number of years a DFCU member
